


**CIVIL SERVICE COMMISSION

ELIGIBILITY LIST FOR POLICE RECRUIT**

The following applicants have successfully passed the written examination given on July 31, 2009, and meet all other minimum qualification requirements for the position. Applicants are listed in order of their written test score. Veterans who submitted proper proof of an honorable discharge by the application deadline and passed the written test have 5 points added to their written test score. In cases where applicants had the same final score, the person who applied first is listed first. This eligibility list will remain in effect until January 31, 2010, unless the list is exhausted before that date. Persons may be removed from this list if they fail the background investigation, oral interview, work fitness examination, or any other part of the selection process. If an applicant's name is removed from the list, the applicant will be notified in writing.
