ORDINANCE NO. <u>0-2014-59</u>

AN ORDINANCE AMENDING THE CITY OF TYLER ZONING ORDINANCE OF THE CODE OF ORDINANCES OF THE CITY OF TYLER, TEXAS; BY CHANGING THE ZONING FROM "R-1B", SINGLE-FAMILY RESIDENTIAL DISTRICT TO "R-1D", SINGLE-FAMILY DETACHED AND ATTACHED RESIDENTIAL DISTRICT ON LOT 2B OF NCB 780B, ONE LOT TOTALING APPROXIMATELY 0.13 ACRES OF LAND LOCATED NORTH OF THE NORTHWEST INTERSECTION OF GUINN DRIVE AND KNOB HILL DRIVE (1815 KNOB HILL DRIVE); DIRECTING THE AMENDMENT OF THE ZONING MAP; DIRECTING THE AMENDMENT OF THE FUTURE LAND USE GUIDE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Planning and Zoning Commission of the City of Tyler, Texas, and the City Council of the City of Tyler, Texas, in compliance with the Charter and the State law with reference to the zoning ordinance of the City of Tyler, Texas, and zoning map, have given requisite notices by publication and otherwise and after holding a due hearing and affording a full and fair hearing to all the property owners, generally and to the persons interested, situated in the affected area and in the vicinity thereof, the City Council is of the opinion that the zoning change should be made as set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That the following zone change is hereby approved as follows:

I. APPLICATION Z07-14-049

That the following described property, which has heretofore been zoned "R-1B", Single-Family Residential District, shall hereafter bear the zoning classification of "R-1D", Single-Family Detached and Attached Residential District, to wit:

Lot 2B of NCB 780B, one lot totaling approximately 0.13 acres of land located north of the northwest intersection of Guinn Drive and Knob Hill Drive (1815 Knob Hill Drive).

- PART 2: That the City Manager is hereby ordered and directed to cause the zoning map to be amended to reflect the above described zoning and amend the Future Land Use Guide from Single-Family Medium/Low Density to Single-Family and Single-Family Attached Medium/High Density.
- PART 3: Should any section, subsection, sentence, provision, clause or phrase be held to be invalid for any reason, such holding shall not render invalid any other section, subsection, sentence, provision, clause or phrase of this ordinance and same are deemed severable for this purpose.
- **PART 4:** That this ordinance shall be effective on and after its date of passage and approval by the City Council.
