## **RESOLUTION NO. R-2011-36**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, RATIFYING THE APPLICATION FOR FEDERAL TRANSIT ADMINISTRATION GRANT FUNDS FOR PUBLIC TRANSPORTATION SERVICE FOR TYLER TRANSIT; RATIFYING ACCEPTANCE OF FEDERAL TRANSIT ADMINISTRATION GRANT NUMBER ED1103 (10) 06 TOTALING \$104,957.00, ALONG WITH ANY GRANT AMENDMENTS TO INCREASE THE GRANT FUNDING LEVELS; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, it is necessary for the City Council to authorize ratification of the application for FTA funds, as well as acceptance of FY 2011 ED1103 (10) 06 Grant and any grant amendments to increase the grant funding levels; and

WHEREAS, this grant supplies reimbursement for a portion of Transit Department purchase of service costs. Remaining funds come from the adopted budget, departmental revenue, and State grant funds. If the City of Tyler did not receive this grant, the City would be responsible for all operating expenses; and

**WHEREAS**, it is considered to be in the public interest to obtain and use grant funds for the above public purposes;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

- **PART 1:** That the Ratification for Federal Assistance for Project No. FY 2110 ED1103 (10) 06 requesting \$104,957.00 for public transportation assistance for Tyler Transit on October 12, 2011, and including all understandings and assurances contained therein, is hereby authorized and approved.
- **PART 2:** That the City Manager's filing of the grant application, and all actions taken in connection therewith, is hereby affirmed.
- **PART 3:** That the City Council hereby resolves and affirms to the Federal Transit Administration that the City of Tyler has legal authority to apply for the grant and to finance and carry out the proposed project.
- **PART 4:** That the City Council hereby resolves and affirms to the Federal Transit Administration the City of Tyler's intent to comply with all of the assurances set forth in the grant agreement and all laws, regulations, and circulars incorporated by reference in the grant agreement.
- **PART 5:** That the City Manager is hereby authorized and directed to accept the grant for Project No. FY 2011 ED1103 (10) 06 Grant and any grant amendments to increase the funding levels.

- **PART 6:** That the City Manager is hereby authorized and directed to take all actions necessary in order to accept and use the grant to fulfill the purposes described above.
- **PART 7:** That the City Manager is hereby authorized and directed to provide such additional information as may be required by the Federal Transit Administration.
  - **PART 8:** That this Resolution shall take effect immediately upon its adoption.
