PRESENTATIONS

P-1 Request that the City Council hear a presentation on City University's One Year Report.

Alexia Hunter, Training Coordinator - Gave a brief one year report on City University. Because of the Blueprint philosophy, the City of Tyler has invested time and resources into the City of Tyler's own City University, known as "City U", an on campus educational institute for employees. City University was officially launched on October 2, 2008 with the intent of providing continuing education courses to employees and fostering an environment of life-long learning within the City.

City University and the programs that have evolved from it are natural evolutions of the Blueprint. City University's mission is to provide high-quality comprehensive training to all City personnel and to serve as a resource for information and tools to enhance the productivity and professionalism of our employees.

City University's curriculum is organized into four tracks; Core Curriculum, Innovation, Professional Development, and Leadership Development. Core Curriculum focuses on basics such as New Employee Orientation and Cash Handling. The Innovation Track focuses on technology skills such as web training and courses on most Microsoft

applications (Word, Excel, PowerPoint, Access and Publisher). Professional Development coursework focuses on those employees seeking to advance their professional skills. These courses include Customer Service, Public Speaking, and Emotional Intelligence.

O-2 Request that the City Council consider adopting an Ordinance amending the Unified Development Code in City Code Chapter 10 by clarifying the Outdoor Transient Vendor provisions to state specifically that the sale of animals is governed by such provisions, specifying Code Enforcement Department authority to enforce Outdoor Transient Vendor provisions, amending the Outdoor Transient Vendor fee provisions, and providing for exceptions. (O-2010-19)

O-3 Request that the City Council consider adopting an Ordinance amending the Unified Development Code in Tyler City Code Chapter 10 by amending regulations relating to zoning, use regulations, subdivision design and improvements, streets and thoroughfares, development standards, environmental regulations, temporary signs and permits, exempt/prohibited signs, definitions, and fences and walls regulations on the use of electric fences. (O-2010-20) except Section 10-134 (to be reviewed later)

Motion by Mayor Pro Tem Sanders to approve subject to 10-134 being reviewed later; seconded by Councilman Alworth; motion carried 6 - 0 & approved as presented.

O-4 Request that the City Council consider adopting an Ordinance amending Chapter 8, "Parks", Article I. "In General", Section 8-3, "Naming and renaming park lands and facilities", in order to amend the guidelines for naming and renaming park lands and facilities. (O-2010-21)

Motion by Councilman Alworth; seconded by Councilman Whatley; motion carried 6 - 0 & approved as presented.
