<u>Verna Hall, 1018 Wilmington Pl, Tyler Museum of Arts</u> – Thanked the City Council for the support given over the past years. Mrs. Hall asked the City Council to reconsider funding the Tyler Museum of Art.

Reneta Nunn, 119 Settlers Court, Palestine, Tx. – Spoke in favor of the Tyler Museum of Art.

John Gibson, 1147 Fairway Dr. W. Hideaway, Tx. 75771— Stated that he was impressed with Tyler and all the different cultural tourism draws that it offers. Mr. Gibson asked City Council to stay in this beneficial partnership with the Tyler Museum of Art now and in the future.

<u>Larry Meckley, 401 Sutherland</u> – Stated that this budget is unacceptable and City Council cares more about rebuilding downtown Tyler than other things.

Susan Thomae-Morphew, 3416 Cameron Avenue, Executive Director of the UT Tyler Cowen Fine and Performing Art Center – Stated that she was here to address the Hotel Motel tax and the omission of the Tyler Museum of Art for funding. She stated that it is heartbreaking for the City to not find balance in the institutional support of this forty one year old organization while exploring and investing in new. Mrs. Morphew asked City Council to reconsider their support of the Tyler Museum of Art and once again open the door for all organizations providing these services for our great City to apply for HOT funding and for all of us to flourish.

<u>Mitzie Avera, 1358 W. Richards, St. Paul Childrens</u> – Wanted to express their thanks to the City Council for their support.

<u>Councilmember Heines</u> – Stated that he was inclined to reinstate the Tyler Museum of Art back in the budget however he has some issues that could possibly be discussed at the next meeting. In the submission, the organization did not have core audits for the last two years and the budget was an accrual instead of actual numbers. Also he would like a full accounting of the capital plan, request a slot on the board, and prior to funding discuss, what are the future plans for the organization.

<u>Councilmember Mezayek</u> – Stated that he would be concerned if the money the City is providing is an exorbitant amount of their budget funding and if we are the main funding source then that is problematic.

<u>Councilmember Bowdre</u> – Stated that precedent has been set with past councils that you take a look at what the organization was funding, the fiscal accountability and once they meet these benchmarks, we will go back with the organization.
