P-1 Request that the City Council consider receiving a presentation of the final draft of the Tyler 1st Comprehensive Plan.

February 26, 2014

<u>Heather Nick, Planning Director</u> – Stated that the Tyler City Council voted unanimously to adopt the Tyler 21 Comprehensive Plan at their meeting November 14, 2007. The 20-year plan creates a strategic framework for future actions for the City and acts as a roadmap as the City continues to grow. The plan addresses issues such as downtown revitalization, historic preservation, parks and recreation, transportation, and housing and neighborhoods. It defines a vision for the future linked to overall goals and policies, and contains strategies and action items for achieving the goals.

P-2 Request that the City Council consider receiving a presentation on a proposed partnership to build a new all-inclusive playground at Southside Park.

Bill Short, 10661 Shady Trail, Dallas, Texas – Stated that The Tyler Area AMBUCS, Tyler Sunrise Rotary, the City of Tyler, and Child's Play Incorporated of Dallas have teamed together to design a playground for all children. The proposed all-inclusive playground would replace the current structure at Southside Park in Tyler. The proposed playground would be funded through donations solicited from the community.

P-3 Request that the City Council hear a presentation of the recommendations from the Arts Center Task Force.

Susan Guthrie, Asst. City Manager – Gave a brief presentation of the recommendations from the Arts Center Task Force. Over the course of the last six months, the task force has met several times to explore the potential uses of the building. They held a visioning session, completed a SWOT analysis, conducted an arts needs analysis, and developed an arts inventory. From all the ideas generated, the group then narrowed the concepts down to nine and broke into small groups to undertake further research. In November, the subcommittees came back together to present their findings. The task force then voted on six final concepts to recommend to the City Council. The final recommendations include an Art Gallery, an Arts Incubator, a Performing/Culinary Art Lab (which includes theatre, film lab with green screen and culinary demonstration area), and a potential Maker Space.
