M-1 Request that the City Council consider authorizing the City Manager to award the construction contract for the West Cumberland Extension Project and Cherryhill Drive Extension to the lowest bidder, Longview Bridge and Road, Limited, in the amount of \$17,972,467.85.

M-2 Request that the City Council consider authorizing the City Manager to sign a Water Rights Contract between the City of Tyler and the Angelina Neches River Authority (ANRA) for the impoundment of 14.75 acre-feet for the small lake feature at the Hotel Conference Center site in the amount of \$22,500, and execute a professional services contract with Adams Engineering for design and construction updates in the amount of \$14,800.

M-3 Request that the City Council consider accepting the annual review of City of Tyler tax abatements regarding Centene, Hood Packaging, Tazza Pronto, and VME Process Systems.

M-4 Request that the City Council consider authorizing the City Manager to execute a contract for the upgrade to the City's Compressed Natural Gas (CNG) fueling station at the Oakwood Complex (Bid 14-020).

<u>David Johnson, 3118 Standford Court</u> – Stated that his concern was the government expansion to a private sector. Mr. Johnson asked City Council to make a just and fair judgment.

Jamal Moharer, 1190 CR 3504 – Stated that he was here as a local tax payer and a CNG contractor. The City RFP specifically asked for the system to American made and what is being proposed is contrary to that. The 50 cent tax credit should not even be discussed because it's not on the books and it does not apply any longer. What they are proposing is a South American compressor without a back-up. Look at the benefits that we are offering and see there is .31 cent difference and does not include any taxable investment.

#### **April 23, 2014**

<u>Charles Stone, Mansfield, Tx.</u> – Stated that he thought that his company would be the low bidder but was not. Mr. Stone stated that he felt the bid that was provided by Mr. Moharer provided easy access to fast filled opportunities and the City should take advantage of that.

Motion by Councilmember Whatley; seconded by Councilmember Mezayek; motion carried 6 - 0 & approved as presented.



M-5 Request that the City Council consider ratifying staff action for the award of the construction contract for the Fair Plaza Garage parking equipment to the low bidder, Skidata, in the amount of \$239,383.

Motion by Mayor Pro Tem Bowdre; seconded by Councilmember Moore; motion carried 6 - 0 & approved as presented.
