Z-7 F10-14-126 ROWLANDS ADDITION, FIRST AMENDMENT

Request that the City Council consider approving a plat for a one lot subdivision containing 1.67 acres of land located at the northwest intersection of North Broadway Avenue and Martin Luther King, Jr. Boulevard, and a waiver of escrow in the amount of \$46,324 for street improvements to North Broadway Avenue and \$58,679 for street improvements to Martin Luther King, Jr. Boulevard.

<u>Councilmember Moore</u> – Stated that this is an area that is in need of development and encouraged the City Council to consider waiving the escrow for Martin Luther King, Jr. Boulevard in addition to North Broadway.

Rea Boudreaux, 1321 S. Broadway — Stated that he was concerned about asking this developer to pay for more roadway improvements because the property in the past has already paid its fair share. Plus presently North Broadway and Martin Luther King already has five lanes a piece. When the proposed sections are done on Martin Luther King, it will still only have four lanes with a raised median or middle turn lane. The proposed improvements adds no extra travel capacity to Martin Luther King except other than added bike lanes. The five (5) foot bike lane was added in the last addition of the Master Street Plan, not only on Martin Luther King but streets all over Tyler. Mr. Boudreaux stated his concern is that the City is adding bike lanes to a project, especially in an existing neighborhood. He stated that those bike lanes shouldn't be funded by the people who own the existing property or by people who are trying to develop tracks in areas where in-fill development is being promoted.

Motion by Councilmember Moore to amend the waiver to include both North Broadway and Martin Luther King in the amount of \$58,679; seconded by Councilmember Warren; motion carried 7 - 0 & approved as amended.

Z-8 F10-14-133 RIGGLE ROBINSON SUBDIVISION, FINAL PLAT

Request that the City Council consider approving a plat for a five lot subdivision containing approximately 2.96 acres of land located west of the southwest intersection of Spur 248 and Old Henderson Highway, and a waiver of escrow in the amount of \$18,644 for street improvements to County Road 219.

<u>Mayor Heines</u> - Suggested that it might be good to recall the Master Street Plan Committee to look at issues, including dedication/payment issues.

Firefighters enter the competition as individuals or in teams. Representatives from around the country compete against each other.

On Sept. 7, 2014, the Tyler Firefighter Combat Challenge "Over 40" Team, consisting of Jeff Barnett, Brandon Davis, Brent Hail, Terry Hawkins and Randy Lee, won first place in the "Over 40" Relay Race at the 2014 Firefighter Combat Challenge Competition held in Arlington, Texas.

Training year-round to represent the Tyler Fire Department and City of Tyler, this dedicated team will be competing again in the National Firefighter Combat Challenge Competition on Oct. 23 through 25, 2014. The event, open to the general public, will be held here in Tyler at the Simons Broadway Square Mall parking lot, just south of Sears.
