RE: City of Tyler Municipal Court Appointment List for Attorney Ad Litem, Guardian Ad Litem, Guardian, Mediator, and Competency Evaluator with State Reporting Requirements, in accordance with Texas Government Code Chapter 36 (Senate Bill 1369), to be posted with other court information and public notices, including but not limited to city website.

You are required to report the following information to the Office of Court Administration, <u>not later than the</u> 15<sup>th</sup> day of each month:

- 1) The name of each person appointed by the court in the preceding month;
- 2) The name of the judge and the date of the order approving compensation to be paid to a person appointed;
- 3) The number and style of the case;
- 4) The number of cases to which each person was appointed in the preceding month;
- 5) The total compensation paid to each person appointed and the source of compensation;
- 6) The number of hours billed for the work performed and the billed expenses, if the total amount paid to a person in one case in the preceding month exceeds \$1000.00;
- 7) If no appointment was made during the preceding month, the clerk must submit a report indicating the same.

Failure to comply will result in the court's ineligibility for any grant money awarded by the state or a state agency for the next state fiscal biennium.
