RESOLUTION NO. R-2024-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AUTHORIZING THE CITY MANAGER, AS THE DESIGNATED REPRESENTATIVE OF THE CITY OF TYLER, TO EXECUTE ADVANCE FUNDING AGREEMENTS (AFA) c; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, it is the intent of the City Council to protect the public health, safety and welfare; and

WHEREAS, the federal Carbon Reduction Program (CRP) is administered by the Texas Department of Transportation (the State) to support efforts to reduce carbon dioxide (CO2) emissions from the transportation sector in Texas; and

WHEREAS, the City of Tyler, hereinafter referred to as the Local Government, has identified traffic signal improvements located at N Palace Ave at W Bow St, N Palace Ave at W Oakwood St, N Palace Ave at W Erwin St, Palace Ave at W Front St, W Front St at S Vine Ave, W Front St at S Bonner Ave, E Front St at S Fannin Ave, E Front St at S Beckham Ave, S Glenwood Blvd at W Front St, S Glenwood Blvd at W Erwin St, and S Glenwood Blvd at W Houston St, State Control-Section-Job (CSJ) Number 0910-16-185; and

WHEREAS, the Local Government has identified pedestrian signal improvements located at Front St. and Beckham Ave, Glenwood Blvd and Front St., 5th St. and Beckham Ave, S. Broadway Ave and Loop 323, and Old Jacksonville Hwy and Sunnybrook Dr., State Control-Section-Job (CSJ) Number 0910-16-187; and

WHEREAS, projects to improve signal and pedestrian detection and operations are included in the currently approved program of projects as authorized by the Texas Transportation Commission Minute Order Number 116292. Dated August 20, 2022; and

WHEREAS, the estimated costs for these projects are funded 100% with federal Carbon Reduction Program funds with the use of \$209,006.81 Transportation Development Credits (TDCs) for CSJ Number 0910-16-185 and \$233,575.32 TDCs for CSJ Number 0910-16-187 as the City's participation in lieu of a local cash match; and

WHEREAS, the typical estimated local match fund participation requirement for federally-eligible items of work is waived in full for CSJ 0910-16-185 and CSJ 0910-16-187; and

WHEREAS, any non-eligible items of work will be paid by the Local Government; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

Part 1: That the Local Government approves the execution of Advance Funding Agreements (AFA) with the Texas Department of Transportation, and the City Manager of the City of Tyler, Texas, is authorized to execute the AFA on behalf of the Local Government.

PART 2: That the City Manager's filing of the AFA application, and all actions taken in connection therewith, are hereby affirmed.

PART 3: That the City Council hereby resolves and affirms to the Texas Department of Transportation that the City of Tyler has the legal authority to apply for the AFA, execute the proposed projects, and, if necessary, finance the proposed projects.

PART 4: That the City Council hereby resolves and affirms to the Texas Department of Transportation, the City of Tyler's intent to comply with all of the assurances outlined in the AFA and all laws, regulations, and circulars incorporated by reference in the AFA.

PART 5: That the City Manager is hereby authorized and directed to provide such additional information as may be required by the Texas Department of Transportation.

PART 6: That this Resolution shall take effect immediately upon its adoption.
