ORDINANCE NO. O-2024-85

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AMENDING CHAPTER 6 "BUILDINGS AND STRUCTURES", CHAPTER 8 "PARKS", CHAPTER 10 "TYLER UNIFIED DEVELOPMENT CODE", CHAPTER 16 "SOLID WASTE DISPOSAL REGULATION", AND CHAPTER 19 "UTILITIES" OF THE CODE OF ORDINANCES OF THE CITY OF TYLER, TEXAS, BY AMENDING AND UPDATING VARIOUS FEES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, various fees for services are established in the City Code; and

WHEREAS, it is important for the City Council to update and revise various fees in the City Code;

WHEREAS, Texas Local Government Code Section 214.908(a) defines "building permit fee" as a fee charged by a municipality as a condition to constructing, renovating, or remodeling a structure; and

WHEREAS, Texas Local Government Code Section 214.908(b) provides that a building fee is abolished on the 10th anniversary date the fee is adopted or most recently reauthorized under Section 214.908, unless the municipality that adopted or reauthorized the fee (1) holds a public hearing on the reauthorization of the fee; and (2) reauthorizes the fee by vote of the governing body; and

WHEREAS, on September 11, 2024, the Tyler City Council conducted a public hearing in accordance with Texas Local Government Code Section 214.908;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS;

PART 1: That Tyler City Code Chapter 6, "Buildings and Structures", Article VIII, "Fire Prevention", is hereby amended by adopting, revising and/or reauthorizing miscellaneous fees by amending Section 6-127 to read as follows:

Sec. 6-127. Permits; Miscellaneous fees.

All permits issued by the Fire Department shall be valid for a period of six (6) months from the date of issuance, except as otherwise provided in this Article.

PART 2: That Tyler City Code Chapter 6, "Buildings and Structures", Article I, "Building Code", is hereby amended by adopting, revising and/or reauthorizing miscellaneous fees by amending Section 6-3 to read as follows:

Sec. 6-3. SCHEDULE OF PERMIT FEES

a. Building permit fees.

1. New residential construction fees shall be \$0.35 per each square foot of building space. Residential construction shall include all single family detached residences and single family attached residences including duplexes, townhomes and condominiums. Minimum fee fifty dollars (\$50.00).

2. Nonresidential, commercial and industrial new construction and alteration, additions and repairs. Building permit and fire inspection fees, not including plumbing and electrical permits and inspections fees, on all nonresidential, commercial and industrial new construction and alteration, additions and repairs, shall be five dollars (\$5.00) per each one thousand dollars (\$1,000.00) of estimated construction valuation. Minimum fee fifty dollars (\$50.00).

3. Residential, alteration, additions and repairs fees shall be \$0.35 per each square foot of area being remodeled, altered, added, or repaired. The minimum fee for any type of permit shall be fifty dollars (\$50.00).

- 4. When the estimated construction valuation is not available, or the provided estimate of construction valuation is, in the opinion of the Chief Building Official, not consistent with business or industry-wide construction valuation standards, the Chief Building Official may assign the valuation in accordance with the latest Building Valuation Data, as published by the International Code Council.
- 5. The fee for reinspection shall be fifty dollars (\$50.00).
- 6. The fee for plan review shall be twenty-five (25) percent of the permit fee, to be paid when plans are submitted for nonresidential, commercial, and industrial plans. The fee for plan review shall be twenty (20) percent of the permit fee, to be paid when plans are submitted for new residential, residential alteration, addition or repair. If staffing is available, expedited plan review fees for non-civil plans shall be three hundred (300) percent of the normal permit fee plus one hundred (100) dollars per hour. The fee applies to voluntary requests for expedited plan review from applicants.
- 7. Clean and Show \$30.00
 - b. Cooling and heating systems:
 - 1. Minimum permit fee-fifty dollars (\$50.00).
- 2. Fee for inspecting heating, ventilating, ductwork, air-conditioning and refrigeration systems shall be minimum fifty dollars (\$50.00).
 - 3. Fee for inspecting repairs, alterations and additions to an existing system

shall be Fifty dollars (\$50.00).

- 4. If it is necessary to make a reinspection of a heating, ventilating, air conditioning or refrigeration system, or boiler installation, the installer of such equipment shall pay a reinspection fee of Fifty dollars (\$50.00).
- 5. When preliminary inspection is requested for purposes permitting temporary operation of heating, ventilating, refrigeration, or air conditioning system, or portion thereof, a fee of fifty dollars (\$50.00) shall be paid by the contractor requesting such preliminary inspection. If the system is not approved for temporary operation on the first preliminary inspection, the usual reinspection fee of fifty dollars (\$50.00) shall be charged for each subsequent preliminary inspection for such purpose.
- 6. Building Contractor's Registration: *fifty dollars (\$50.00)* (to expire December 31 of each (year). At the time of registration, applicants for registration that are seeking to build, alter or remodel one- or two-family residences shall submit to the Building Inspection Department proof that they have made application for the appropriate State registration as well.

In the event any building or structure is started without a permit, the above fees will be increased one hundred (100) percent. PART 3: That Tyler City Code Chapter 8, "Parks", Article V., "Fees", is hereby amended by adopting, revising and/or reauthorizing miscellaneous fees by amending Section 8-76 to read as follows:

Sec. 8-76. Special event permit fee; park pavilions and restrooms.

The rates and charges for special event permit fees, park pavilions, and restrooms are provided in this section. All such rates and charges shall be paid in advance. The rates shall be determined in accordance with the following:

- a. Unless otherwise specifically provided, the fee for a special event permit shall be fifty dollars (\$50.00).
- b. A fee of fifty dollars (\$50.00) shall be charged for the rental of park pavilions and restrooms. A fee of three hundred dollars (\$300.00) shall be charged for vendor shows. A vendor show is defined as any event that takes up a majority of the park rented. The Parks Director shall use his/her discretion to determine if an event is designed as a "vendor show." (Ord. - c. Bergfeld Park amphitheater-A fee of three hundred dollars (\$300.00) per day and a damage deposit of one hundred fifty dollars (\$150) to five hundred dollars (\$500.00) shall be charged for the rental of the amphitheater at Bergfeld Park.
- i. Mowing Request-If a special request is needed for the space to be mowed outside of the normal mowing schedule, a fee of one hundred dollars (\$100.00) will be charged.
- ii. All amplified events will require paid Parks staff at the expense of the PERMITTEE at a ratio of one (1) employee per 300 attendees, at a rate of \$25.00 per hour, per employee. (Ord. References to the existing Publication Fee, Refundable Zoning Sign Deposit and Recording Fee are deleted from the Chart above and are included below. These existing fees [a], [b], and [c], are added to the fees above, where applicable. The intent is to include these existing fees with the fees above, where applicable, to make payment easier. In addition, the Notification Fee, which historically has been mailed to the applicant after the total number of required mailings has been determined, has been added as a lump sum to allow applicants to pay all fees upfront. Staff performed a study on the average number of notices sent per zoning case, and determined the average Notification Fee to be \$20.00. Therefore, the current reference to a .50 Notification Fee per mailed notification is deleted.

- [a] Includes mandatory publication and mailed notification required for owners whose property is within 200 feet of the proposed action.
- [b] Includes \$20 Zoning Sign Deposit (refundable upon sign's return)

- I.R. = Ms + (Rate per 1,000 gals.)(Vs-2) + [(COD Surcharge)(COD-300) + (TSS Surcharge) (TSS-250)Vs where:
- Mw = The minimum rate for sewer utility use based on the size of water meter.
- Ms = The minimum rate for sewer utility use based on the size of water meter, or on the water meter size equivalent.
- Vw = The total volume of water used during the month (in thousands of gallons).
- Vs = The total volume of sewage discharged during the month (in thousands of gallons).
- COD = The established chemical oxygen demand strength of the industrial waste discharged, based on laboratory analyses, and expressed in milligrams per liter (mg/l).
- TSS = The established total suspended solids concentration of the industrial waste discharged, based on laboratory analyses, and expressed in milligrams per liter (mg/l).
- 250 = The surcharge limit for TSS established in the industrial waste ordinance, expressed in milligrams per liter (mg/l).
- 300 = The surcharge limit for COD established in the industrial waste ordinance, expressed in milligrams per liter (mg/l).
- f. Rates for services to industrial waste dischargers outside the city limits shall be multiplied by a factor of 1.5. (Ord. No. O-96-54, 6-26-96) (Ord. No. 0-98-74, 9/2/98) (Ord. No. 0-99-70, 10-1-99) (Ord. No. 0-2022-87; 9/14/2022) (Ord. No. 0-2024-85; 9/11/24)

Grease", Division 1., "Liquid Waste Transportation and Disposal", is hereby amended by adopting, revising and/or reauthorizing miscellaneous fees by amending Section 19-102 to read as follows:

Sec. 19-102. Application procedure for permit; fees; duration of permit; permit non-transferable.

- a. The Permit required by this Article shall be secured prior to operation of a vehicle as transporter to any disposal facility.
- b. Applications may be obtained during business hours from the Manager at 511 West Locust, Tyler, Texas, 75702.
- c. Applications must be submitted on a form provided for that purpose by the Manager. The application form must be filled in completely, signed by the applicant and verified before a notary public.
 - d. Each applicant shall provide the following information on the application:
 - Name (owner and business);
 - Address (residence and business);
 - 3. Owner's social security number;
 - 4. Telephone numbers (residence, business, emergency);
 - 5. Texas Natural Resource Conservation Commission (TNRCC) registration

number;

- 6. The vehicle identification number (VIN) of each vehicle to be permitted;
- 7. The license number of each vehicle to be permitted; public.
- 8. Year, make and model of each vehicle to be permitted;
- 9. Gallon capacity of each vehicle to be permitted;
- 10. A description of metering equipment with which each such vehicle is

equipped;

- 11. A color photograph of each disposal vehicle;
- 12. A photocopy of each driver's motor vehicle operator's license;
- 13. Such other information or data that the Manager may deem necessary to the administration of this article.
- e. Each application shall be accompanied by a permit fee of thirty dollars (\$30.00) for the first vehicle to be permitted and twenty dollars (\$20.00) for each additional vehicle to be permitted (maximum of three (3) vehicles per permit). The same fees will apply to annual renewals and will be payable within thirty (30) days of that renewal (normally January first).
- f. A Permit issued hereunder shall be valid for a period of one (1) year from the date of issuance unless earlier revoked or suspended in accordance with the provisions of this article.
- g. A Permit issued under the authority of this article may not be sold, assigned or otherwise transferred nor inure to the benefit of any transporter other than the original permittee.
- h. The fee for disposal of septage at a City disposal facility is *Hundred Dollars* (\$100.00) per one thousand (1,000) gallons. (Ord. No. 0-2021-91; 9/22/21)(Ord. No. 0-2022-87; 09/14/22)(Ord. No. 0-2023-85;9/13/23) (Ord. No. 0-2024-85; 9/11/24)
- i. Trip tickets for each load of septage disposed at a City disposal facility will be forwarded to the Office of the Manager, Water Utilities Department for billing. A statement will be rendered within the first two (2) weeks of each month for the preceding month's discharges. The statement shall identify the quantity (in thousands of gallons) of septage.

j. In the event the volumes of septage received at City facilities decrease substantially and the Manager determines that significant unauthorized waste disposal has resulted as a consequence of the increase in rates, the Manager is authorized to adjust the rate downward for disposal of septage, but in no case may the rate be adjusted so that it is less than the cost for the City to provide the service. PART 8: That if any provision or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way affect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 9: That any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine as provided in Section 1-4 of the Tyler Code. Each day such violation shall continue, or be permitted to continue, shall be deemed a separate offense. Since this ordinance has a penalty for violation, it shall not become effective until its publication in the newspaper as provided by Section 85 of the Charter of the City of Tyler, Texas, or later. The effective date of this Ordinance shall be October 1, 2024.
