Item Reference: Half Mile of History Preservation Program

The Half Mile of History is a cultural and historic landmark program paying tribute to people, places and events that have contributed to the City of Tyler and/or Smith County. The Half Mile of History is a permanent, outdoor walk-around loop that covers an approximate one-half mile stretch of sidewalk surrounding the square in the heart of downtown Tyler. People, places and events chosen for the Half Mile of History are honored with a commemorative plaque placed in the sidewalk.

One of the responsibilities of the Tyler Historical Preservation Board is to recommend people, places and events to be included in the Half Mile of History Preservation Program. On July 2, 2008, the Tyler Historical Preservation Board voted unanimously to recommend Senator Tomas Glover Pollard for inclusion in the Half Mile of History Preservation Program. A brief narrative follows.

Tomas Glover Pollard was born May 9, 1895, in Martins Mill of Van Zandt County, Texas, the son of Mr. & Mrs. William Benjamin Pollard. Mr. Pollard graduated from Athens High School and then attended and graduated from the University of Texas in Austin with his law degree in 1922. As well as being in the House of Representatives for three years, he was elected and served as U.S. Senator for ten years. While in government, he was instrumental in passing education bills for rural communities, as well as the oil and gas bills and transportation funding bills that benefit the East Texas citizens today.

After moving to Tyler with his wife, Edna, in 1922, he obtained a charter and helped open Tyler's first state bank in 1924. Once finished with his public service, he concentrated on his law practice and land development. His family deeded a ten acre tract of land in southeast Tyler to the Tyler Independent School District. He developed the Pollard Home, Pollard Hills, Pollard School Subdivision and the Briarwood Addition. His family home, currently called Ravenwood, (owned by the Ellis Family) was designated as a Tyler Historic Landmark in 1998 and then accepted into the Smithsonian Institution of American Gardens in 1999. He also donated a gift to the Methodist Church in the early 1950's to create the Pollard United Methodist Church. He was an active member in the Rotary Club, Tyler Chamber of Commerce and the American Rose Society. After the Senator's death in 1962, another gift was given to the City of Tyler to create the Pollard Park in his honor.

For these and many other reasons, Senator Tomas Pollard should be recognized for his lasting contributions to the City of Tyler and Smith County.

RECOMMENDATION:

The Tyler Historical Preservation Board recommends by a vote of 6-0 that the City Council designate Senator Tomas Glover Pollard as a Half Mile of History recipient.

City of Tyler: Half Mile of History

Tomas Glover Pollard

When one thinks about citizens in Tyler that greatly affected the local community, many names come to mind; one of which is Tomas Glover Pollard. Tomas Glover Pollard was born in Martins Mill on May 9, 1895 to Mr. and Mrs. William Benjamin Pollard. This man from the Piney Woods grew up to do extraordinary things for his country, his state, and his local community. Mr. Pollard significantly contributed to the community in many ways, such as the areas of education, government, law, and oil and gas. He was dearly devoted to his family, his country, his state, and especially devoted to the city of Tyler.

Pollard's devotion to education began early, as he graduated from Athens High School in 1915. He then traveled to Austin to attend the University of Texas in 1915-1917, earning his Bachelor of Arts degree in 1920 after a stint in the U.S. Aviation section of the army. He continued his education in law at the university and received his LL. B. degree in 1922. During his time at the university, Pollard was the Business Manager for the Longhorn Magazine from 1919-1921, and then served as the business manager of the Texas Student Publications, Inc. from 1921-1923. As Pollard pursued his career, education was still close to his heart. During his tenure as Senator, he passed the Pollard Rural School Aid Bill on January 27, 1929, which appropriated \$5,000,000 each year for education in rural communities. Pollard also noted that the area of West Texas was in need of a college, so he helped to sponsor a bill that created a college for that part of the state: Texas Technological College. During the years of 1935-1941, Pollard served on the Board of Regents for Texas Technological College in Lubbock, Texas. On November 10, 1953, the Pollard family deeded a 10-acre tract of land in Southeast Tyler to the Tyler public schools for future school needs. Years later, Tyler Independent School District named Mr. and Mrs. Tomas G. Pollard among their '120 Heroes' for their contributions to local public education.

Among several others, Pollard's passions involved politics and government. While he was a student at the University of Texas in 1917, he entered the Aviation Section of the United States Army. After serving his country, he was honorably discharged on January 10, 1919 as First Lieutenant Military Reserve Aviator. Pollard returned to school that same year, and he was elected to the House of Representatives in Van Zandt County, being the youngest Representative at that point to go to the Legislature from that district. In 1920, Pollard was re-elected to the House of Representatives. Pollard's fervor for politics and government grew from there, as he continued his education as well as his campaign for Senate. In 1922, Tomas G. Pollard was elected as Senator of the Seventh Senatorial District without opposition, and he served on the Senate for 10 years.

During his career as Senator, Pollard served his country, state, and community well. Senator Pollard and his new wife, Edna Martin Pollard, moved to Tyler in 1922 and began to recognize the needs of their local community. Pollard noted that in those years, Tyler had no local state bank, only national banks. On April 8, 1924, Pollard obtained a charter and helped to open Tyler's first state bank, Tyler Guarantee Bank (also known as the Tyler Bank and Trust Company). He served as Vice President, Director, and Attorney for the Tyler State Bank and Trust Company for several years as well as being the Vice President, Director, and Attorney for the East Texas Building, Loan & Savings Association of Tyler. He also noted that transportation in Tyler was often difficult because only 5 miles of the 130 miles of road in the area were paved. Senator Pollard passed a bill that allowed additional funding for the roads as well as reducing the amount of weight that was carried on these roads so they could last longer. From 1928 to 1932,

Pollard served as the youngest Chairman of the Finance Committee of the Senate at 33 years old. His political career continued to be successful, as he was elected President Pro Tempore of the 40th Legislature of the Texas Senate on May 9, 1927. Today, Senator Pollard is the 5th youngest President Pro Tempore in history, being only 31 years old at the time.

Pollard also made several contributions in the area of law. Though most of his career was spent in politics, he continued to practice law in his spare time. He began his law career in Tyler as a collection attorney, and then went on to represent the Tyler Bank and Trust Company as well as Mass-Tex Oil and Gas Company in Dallas in 1945. He also was a member of Pollard and Lawrence law firm, which was a Civil Law Practice representing oil men and other independent classes of business. He served as the vice-chairman of the Legislative Council Committee for the State Bar of Texas during 1949 through 1951, and on April 24, 1950, he was elected Chairman of the advisory board of the Southwestern Legal Foundation.

Among his many lasting contributions to the state and community is his involvement with the Oil and Gas industry. This was an area that hit home to many Tyler citizens and citizens of East Texas as oil became popular. In an effort to enable small businesses in this industry to work efficiently and competitively with the larger oil companies, Senator Pollard authored the Oil and Gas Pipeline Bill as well as the Gas and Market Demand Conservation Statutes in 1931 and 1932. These bills aided the small oil and gas companies that were struggling to survive against the larger companies in the Northeast. Although many years have passed since these bills were created, the people of East Texas are still reaping the benefits today.

After Senator Pollard and his wife moved to Tyler, they began to settle in their new community as a family. In 1929, the Pollards bought an 18-acre farm in the city, which eventually expanded to several hundred acres of beautiful land and well-known gardens. This magnificent estate was the home to Mr. and Mrs. Pollard and their three children: Tomas Jr., Mary, and Jack. The estate, currently called Ravenwood and owned by the Ellis family, was designated a Tyler Historic Landmark in 1998 and then accepted into the Smithsonian Institution of American Gardens in 1999. Pollard maintained his interest in the land of Tyler by developing Pollard Home, Pollard Hills, and Pollard School subdivisions beginning after World War II. He was also involved in Verbena Hills and Donnybrook Heights subdivisions. The Pollard Estate continued the expansion of Senator Pollard's land with the development of Briarwood Addition. These subdivisions basically follow the path of Pollard Avenue from Troup Highway to Loop 323.

The Pollard family continued to give back to the community, donating a partial gift to the Methodist Church in the early 1950's to create Pollard United Methodist Church. After the death of Senator Tomas Glover Pollard on October 19, 1962, the Pollard family continued to carry on his tradition of generosity by giving a partial gift in March of 1970 to the city of Tyler to create Pollard Park for the citizens of Tyler to enjoy.

Among Senator Tomas G. Pollard's many areas of involvement, he was a member of the Rotary from 1929-1960 with perfect attendance, was active in the Tyler Chamber of Commerce, and an American Rose Society member. He is remembered well by his family members, friends, and by members of the community. In a statement by Carl Wallace in the Tyler Courier-Times after Senator Pollard's death, it is said that he succeeded in all of his endeavors "all the while maintaining the broad and intimate associations through which his life took on the quality of good neighbor and warm-hearted friend. It is likely that for that quality most people will remember him, and it is certainly one of the best ways in which to be remembered." It is for this reason, among the many mentioned above, that Senator Tomas G. Pollard should be recognized for his lasting contributions and enduring impact on the community, county, region, and the state of Texas.
