Item Reference: Half Mile of History Preservation Program

The Half Mile of History is a cultural and historic landmark program paying tribute to people, places and events that have contributed to the City of Tyler and/or Smith County. The Half Mile of History is a permanent, outdoor walk-around loop that covers an approximate one-half mile stretch of sidewalk surrounding the square in the heart of downtown Tyler. People, places and events chosen for the Half Mile of History are honored with a commemorative plaque placed in the sidewalk.

One of the responsibilities of the Tyler Historical Preservation Board is to recommend people, places and events to be included in the Half Mile of History Preservation Program. On August 6, 2008, the Tyler Historical Preservation Board voted unanimously to recommend Wood T. Brookshire for inclusion in the Half Mile of History Preservation Program. A brief narrative follows.

Wood T. Brookshire moved to Tyler in 1928 and opened his first store on the east side of the downtown square. This small 2,500 square feet store would prove to be the cornerstone for today's Brookshire Grocery Co. The company had the distinction of operating the first air-conditioned grocery store in East Texas, at the corner of Front Street and Broadway. Today, Brookshire Grocery Company has more than 150 supermarkets operating in Texas, Louisiana, Arkansas and Mississippi. As the company grew, Brookshire's opened it's first warehouse on Dean Street in 1953. The Tyler Distribution Center opened in its current location on South Loop 323 in 1968. Under Mr. Brookshire's leadership the company has thrived and currently operates three distribution facilities with more than two million square footage, and employs approximately 12,000 people (of which 2,500 are in Smith County).

In addition to providing fair-priced products of the highest quality for Tyler consumers, Mr. Brookshire was the director of the Tyler Chamber of Commerce in 1945 and served on the Tyler School Board from 1941 to 1950. Brookshire's also built the Brookshire's World of Wildlife Museum and Country Store in Tyler, which hosts more than 40,000 visitors annually. With Mr. Brookshire's strong belief in being involved in the Tyler community, Brookshire's Company continues its commitment in helping local charities and schools.

RECOMMENDATION:

The Tyler Historical Preservation Board recommends by a vote of 8-0 that the City Council designate Wood T. Brookshire as a Half Mile of History recipient.

Wood T. Brookshire opened his first store near the downtown square in Tyler, Texas, in 1928. This small 25 x 100-foot store served as the beginning of today's Brookshire Grocery Company. Today, Brookshire Grocery Co. has more than 150 supermarkets operating in Texas, Louisiana, Arkansas and Mississippi.

The grocery business was a very competitive industry with numerous stores in Tyler when Wood opened that first store in 1928. At his memorial service in 1977, Dr. W.M. Shamburger, then pastor of Tyler's First Baptist Church, said, "In 1928 he was numbered among 1,000 grocerymen in East Texas. Today, he stands alone at the top."

Wood succeeded by founding the company with strong convictions in a "people first" operating philosophy, encouraging a service-driven attitude among all who worked along side him and rewarding them with competitive wages and generous benefits. He created the company's profit-sharing plan in 1960. He truly believed the grocery business was his calling – a way for him to serve his fellowmen by providing fair-priced products of the highest quality for consumers and a partner-style work environment for employees.

Wood also believed in being involved in the communities where the company operates, including Tyler. For example, he gave a \$1,000 scholarship grant to a deserving Tyler Junior College student in 1966. At the time, it was the largest presented to any one TJC student. He was the director of the Tyler Chamber of Commerce in 1945 and served on the Tyler School Board from 1941 to 1950.

Brookshire's made history in several ways during its early days under Wood's leadership. The company had the distinction of operating the first air-conditioned grocery store in East Texas, at the corner of Front Street and Broadway in Tyler. This store opened in 1939 after fire destroyed another location. When Bergfeld Shopping Center debuted in the 1940s, it featured a brand-new Brookshire's store. Today, Brookshire's still stands in this historic shopping district – a newer, larger version with modern amenities yet the same friendly charm as always.

As the company grew, with stores starting to pop up across East Texas, Brookshire's opened its first warehouse on Dean Street in 1953. The Tyler Distribution Center opened in its current location on South Loop 323 in Tyler in 1968.
