- M-5 Request the City Council consider authorizing the City Manager to award The Interlocal Purchasing System (TIPS) contract number 170201 for Faulkner Park skate park construction to Transcend, Inc. d/b/a SPA Skateparks of Austin, Texas to furnish all necessary materials, equipment, superintendence, and labor for an amount not to exceed \$188,220.
