RESOLUTIONS

R-1 Request that the City Council receive a presentation and consider a Resolution adopting the final draft of the regional pedestrian and bicycle master plan called Active Tyler as a guide for making decisions for the future growth and development of pedestrian and bicycle infrastructure in the City of Tyler. (R-2019-14)

<u>Jared Draper, Toole Design Group</u> – Gave a brief update on the master plan called Active Tyler.

<u>Carlos Leguizamo</u>, 2301 Glenview Ave – Spoke in favor of the project.

Motion by Mayor Pro Tem Sellers; seconded by Councilmember McGee; motion carried 7 - 0 & approved as presented.

R-2 Request that the City Council conduct a public hearing to consider adoption of a Resolution authorizing tax-exempt financing by the Oglesby Education Facilities Corporation for the benefit of Cumberland Academy, with no financial obligation to the City of Tyler. (R-2019-15)

Mayor Heines opened up the public hearing on both Items R-2 and R-3 at 9:43 am

Motion by Councilmember Westbrook; seconded by Councilmember Nix; motion carried 7 - 0 & approved as presented.

R-3 Request that the City Council conduct a public hearing to consider adoption of a Resolution authorizing tax-exempt financing by the Creedmoor Education Facilities Corporation for the benefit of Cumberland Academy, with no financial obligation to the City of Tyler. (R-2019-16)

William Frazier, 1720 Jeff Davis Dr. – Concerned about traffic and people parking in his driveway.

<u>Dustin Neuland</u>, 1708 Jeff Davis Dr. – Concerned about the traffic, the one entrance, and one exit out of the school.

<u>Councilmember Nix</u> - Stated that Barbara Bass ask that City Council try and find some kind of resolution for the problem at Cumberland Academy. Councilmember Nix also read a letter from Jane and Ron Hightower, 1819 Jeff Davis Dr. concerning traffic, potholes and people turning into their driveway.

<u>Councilmember Nix</u> - Ask that Cumberland Academy find a way to control traffic when they are performing construction on their property.

Norma Cotton, 17715 CR 223, Arp, Texas – Stated that because of the construction they are not able to go around the building for a few weeks and had to cut out traffic flow.

<u>Mayor Heines</u> - Expressed a concern to Mrs. Cotton that it has always been a request for the Academy to handle their pick up and drop off on their site. Mr. Heines also asked Mrs. Cotton to commit to building another exit-entrance at Cumberland Academy and handle their parking.

<u>Norma Cotton</u> – Spoke on behalf of Cumberland Academy. Stated that Cumberland Academy would commit to building a second entrance at Cumberland Academy and to handling the pickup and delivery of students on site within the next 90 days. Also, agreed to discuss with the Texas Department of Transportation (TxDOT) and City of Tyler on where that entrance would be.

Mayor Heines closed the public hearing at 10:16 am.

M-8 Request that the City Council consider authorizing the City Manager to award Bid No. 19-025 for Southside Park renovations to Watson Commercial Construction, Ltd., of Tyler, Texas, to furnish all necessary materials, equipment, superintendence, and labor in an amount not to exceed \$223,162.97.

Motion by Councilmember Nix; seconded by Councilmember Warren; motion carried 7 - 0 & approved as presented.

M-9 Request that the City Council consider authorizing the City Manager to sign a permanent right-of-way use agreement with Pazzeria by Pietro's for the purpose of installing and maintaining outdoor restaurant seating in the City of Tyler right-of-way. (Mayor exits room prior to discussion.)

- C-A-7 Request that the City Council consider authorizing the City Manager to award Line 50 of City of Tyler Bid No. 19-019, for demolition work at Fun Forest Park to

Garrett and Associates General Contractors of Whitehouse, Texas, in the amount of \$38,270.

- C-A-8 Request that the City Council consider adoption of a Resolution amending polling locations for a previously called Election for May 4, 2019 to fill the office of Tyler City Council Member for Single Member District No. 3, making provisions for and resolving other matters incident and related to such regular election, and reducing the number of voting locations related thereto. (R-2019-17)
- C-A-9 Request that the City Council consider adopting a Resolution authorizing the City of Tyler's continued participation with the Atmos Cities Steering Committee, and authorizing the payment of five cents per capita (\$5,450.00) to the Atmos Cities Steering Committee to fund regulatory and associated activities related to Atmos Energy Corporation. CITY MANAGER'S REPORT

- 1. Transit has applied for Enhanced Mobility of Seniors & Individuals with Disabilities Section 5310 Funds. These funds would allow Tyler Transit to improve mobility for seniors and individuals with disabilities by removing barriers to transportation service and expanding transportation mobility options. In addition, this funding source allows Tyler Transit to assist private nonprofit groups in meeting the transportation needs of older adults and people with disabilities when the transportation service provided is unavailable, insufficient, or inappropriate to meeting these needs.
- 2. The Second Annual Heart Hunt is happening on April 13. Main Street and Fit City Tyler invite you to explore Downtown in a fun and competitive scavenger hunt. Teams of 2, 3, or 4 will take on the Downtown Heart Hunt starting at 9 am. Teams will have one hour to get the most points by finding hearts around Downtown using hints and then uploading photos of the members with each heart onto social media with the hashtag #DowntownHunt.
- 3. On Tuesday, March 26 at 10 a.m., the City of Tyler, Tyler Pounds Regional Airport announced a new partnership with commercial air carrier Frontier with non-stop destinations to Denver, Colorado.
