O-2 Request that the City Council consider approving an Ordinance prohibiting the use of designated groundwater from beneath the property whose address includes 1700 East Duncan Street, which contains approximately 37.712 acres of land in Tyler, Texas, to facilitate the certification of said property with a Municipal Setting Designation by the

Texas Commission on Environmental Quality, pursuant to the Texas Solid Waste Disposal Act; and providing an effective date. (O-2019-59) (Carrier retains liability).
