R-1 Request that the City Council adopt a Resolution ratifying submission of an application for, and acceptance of, Federal Aviation Administration (FAA) Grant Funds totaling \$10,181,858.00 to fund approximately ninety percent of the 2017 Runway 4/22 Rehabilitation Construction Project – Phase 4 and Engineering construction administration at Tyler Pounds Regional Airport. This resolution authorizes acceptance of any grant amendments to increase the grant funding levels, as well as authorizing the City's match payment not to exceed \$1,192,756.00 for proposed grant projects. (R-2017-30)

R-2 Request that the City Council adopt a Resolution ratifying submission of an application for, and acceptance of, Federal Aviation Administration (FAA) Grant Funds totaling

\$180,000.00 to fund ninety percent of the 2017 Runway 4/22 Rehabilitation Project 4 Land/Easement Acquisition at Tyler Pounds Regional Airport. This resolution authorizes acceptance of any grant amendments to increase the grant funding levels, as well as authorizing the City's match payment not to exceed ten percent (\$20,000.00) for proposed grant projects. (R-2017-31)

O-1 Request that the City Council consider adopting an Ordinance amending and updating fees and other applicable adjustments to Tyler City Code Chapter 6 relating to Buildings and Structures, Chapter 8 relating to Parks, Chapter 10 relating to Tyler Unified Development Code, Chapter 16 relating to Solid Waste Disposal Regulations, and Chapter 19 relating to Water and Sewer. (O-2017-77)

Motion by Mayor Pro Tem Warren seconded by Councilmember Nix to approve O-1 with revision to delete the portion of 0-1 in Part 3, Sec. 8-76, subsection (b) that states:

"A practice fee for youth sports organizations or adult sports organizations to reserve fields for practice for soccer games is hereby established for Lindsey Park as follows:

- 1. Six hundred dollars (\$600.00) per Fall season/per lighted field
- 2. Three hundred dollars (\$300) per Spring season per lighted field.

This Project Grant Agreement is Federal funding, passed through the State, under the 5339 Program in the amount of \$92,738, which includes \$18,548 in Transportation Development Credits for Fiscal Year 2017. This grant will pay 100 percent of RFP 17-026.
