A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, **AUTHORIZING SUBMISSION** TEXAS THE **OF** A APPLICATION WITH THE **EAST TEXAS COUNCIL OF** GOVERNMENTS FOR A REGIONAL SOLID WASTE GRANTS PROGRAM GRANT; AUTHORIZING ANGELA CARDOZA, KEEP TYLER BEAUTIFUL TO ACT ON BEHALF OF THE CITY OF TYLER IN ALL MATTERS RELATED TO THE APPLICATION: AND PLEDGING THAT IF A GRANT IS RECEIVED THE CITY OF TYLER WILL COMPLY WITH THE GRANT REQUIREMENTS OF THE EAST TEXAS COUNCIL OF GOVERNMENTS, THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY; AND THE STATE OF TEXAS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the East Texas Council of Governments is directed by the Texas Commission on Environmental Quality to administer solid waste grant funds for implementation the COG's adopted regional solid waste management plan; and

WHEREAS, the City of Tyler in the State of Texas is qualified to apply for grant funds under the Request for Applications.

WHEREAS, it is considered to be in the public interest to apply for, obtain and use grant funds for the above public purposes;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

- **PART 1.** That Angela Cardoza, Keep Tyler Beautiful, is authorized to submit an application to request grant funding under the East Texas Council of Governments Request for Applications of the Regional Solid Waste Grants Program and act on behalf of the City of Tyler in all matters related to the grant application and any subsequent grant contract and grant project that may result.
- **PART 2.** That if the project is funded, the City of Tyler will comply with the grant requirements of the East Texas Council of Governments, Texas Commission on Environmental Quality, and the State of Texas.
- **PART 3.** That the grant funds and any grant-funded equipment or facilities will be used only for the purposes for which they are intended under the grant application.
- **PART 4.** That activities will comply with and support the adopted regional and local solid waste management plans adopted for the geographical area in which the activities are performed.
- **PART 5.** That the City of Tyler Solid Waste Department is hereby authorized and directed to accept the grant if awarded, and any grant amendments to increase the funding levels.
- **PART 6.** That the Solid Waste Department is hereby authorized and directed to take all actions necessary to accept the grant to fulfill the purposes described above, if awarded.

PART 7. That the Solid Waste Department is hereby authorized and directed to provide such additional information as may be required by the East Texas Council of Governments, the Texas Commission on Environmental Quality, and/or the State of Texas.

PART 8. That this Resolution shall become effective upon its passage and approval.
