

**ORDINANCE NO. O-2018-79**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, ACCEPTING A TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT) ROUTINE AIRPORT MAINTENANCE PROGRAM (RAMP) GRANT TOTALING \$50,000 FOR GENERAL MAINTENANCE PROJECTS AT TYLER POUNDS REGIONAL AIRPORT, AND AMENDING THE BUDGET FOR FISCAL YEAR 2018-2019 AUTHORIZING THE APPROPRIATION OF FUNDS FOR THE FIFTY PERCENT LOCAL SHARE REQUIRED FOR THE 2018-2019 TEXAS DEPARTMENT OF TRANSPORTATION RAMP GRANT; PROVIDING A SEVERABILITY CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS,** The Texas Department of Transportation has offered a \$50,000 RAMP Grant for the maintenance of Tyler Pounds Regional Airport; and

**WHEREAS,** it is the intent of this grant to not supplant local funds normally utilized for airport maintenance, and that any state financial assistance offered under this grant be in addition to those local funds normally dedicated for airport maintenance; and

**WHEREAS,** this budget amendment will provide funding for the City's fifty percent local share required by this grant; and

**WHEREAS,** the City Council hereby authorizes acceptance of the grant;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:**

**PART 1:** That the City is hereby authorize to accept the Texas Department of Transportation (TxDOT) Routine Airport Maintenance Program (RAMP) Grant totaling \$50,000 for general maintenance projects at Tyler Pounds Regional Airport.

**PART 2:** That the following line item accounts as approved in the budget for fiscal year 2018-2019 shall be amended to read as follows:

**PART 4:** That amendment of the fiscal year 2018-2019 Budget is required in order to provide funding for the Texas Department of Transportation RAMP Grant and creates an urgent public necessity to authorize the amendment to the budget herein contained.

**PART 5:** Should any section, subsection, sentence, provision, clause or phrase be held to be invalid for any reason, such holding shall not render invalid any other section, subsection, sentence, provision, clause or phrase of this ordinance and same are deemed severable for this purpose.

**PART 6:** That this ordinance shall take effect immediately upon approval.
