Also request that the City Council consider authorizing the City Manager to purchase (1) Paratransit Low Floor Van through the cooperative with the usage of Transportation Development Credits (TDC's) to offset local match.
- C-A-4 Request that the City Council consider adopting a Resolution agreeing to the sale of certain tracts of land located at 2223 N. Ross within the Tyler city limits and owned by taxing entities including the City of Tyler.
- C-A-5 Request that the City Council consider adopting a Resolution agreeing to the sale of certain tracts of land located at 1008 W 32nd St. within the Tyler city limits and owned by taxing entities including the City of Tyler.
