

- v. **AABC 05-20-01** Request that the Airport Advisory Board consider recommending that the City Council ratify the City Manager's signing of an Easement and Right-of-Way Agreement with Oncor Electric Delivery Company LLC, granting, selling and conveying an easement and right-of-way to provide commercial electrical power to the Federal Aviation Administration (FAA's) new localizer. This easement involves a tract of land that is 0.179 acres located within the airfield of Tyler Pounds Regional Airport.
- VI. **AABC 05-20-02** Request that the Airport Advisory Board consider recommending to the City Council to adopt a Resolution ratifying submission of an application for Federal Aviation Administration (FAA) CARES Act Grant Funds totaling \$1,218,343.00 to fund the Tyler Pounds Regional Airport's operating expenses. This Resolution authorizes acceptance of the Grant.
