AMERICANS WITH DISABILITIES ACT NOTICE

The City of Tyler wants to ensure that City gatherings are accessible to persons with disabilities. WHEREAS, notice of City Gatherings is routinely posted at least 72 hours before the event consistent

with Texas Government Code Sec. 551.043; and

WHEREAS, due to unforeseen circumstances notice was not timely posted for a City Gathering to be held on Thursday, February 4, 2021, 1:00 p.m. at Tyler Fire Station 1, 801 W. Gentry Parkway, Tyler, Texas; and

WHEREAS, information was previously provided to persons planning to attend the event; and

WHEREAS, it would create a severe hardship to persons planning to attend this event if the scheduled event was cancelled; and

WHEREAS, although this notice for the Council Gathering was not posted prior to 72 hours of the event it would result in unnecessary public inconvenience so there is an urgent public necessity that this posting be made and the gathering proceed as originally planned; and

WHEREAS, Texas Gov't Code Sec. 551.045(a) provides that in an emergency or when there is an urgent public necessity, the notice of a meeting or the supplemental notice of a subject added as an item to the agenda for which notice has been posted in accordance with Tex. Gov't Code Chapter 551, Subchapter C. is sufficient if it is posted at least one (1) hour before the meeting is convened;

NOW, THEREFORE, consistent with Texas Gov't Code Sec. 551.045, emergency notice for a City Gathering to be held on Thursday, February 4, 2021, at 1:00 p.m. at Tyler Fire Station 1, 801 W. Gentry Parkway, Tyler, Texas, is hereby posted as follows:
