In cases where applicants had the same final score, the person who applied first is listed first. This eligibility list will remain in effect until September 13, 2021, unless the list is exhausted before that date. Persons may be removed from this list if they fail the background investigation, oral interview, work fitness examination, or any other part of the selection process. If an applicant's name is removed from the list, the applicant will be notified in writing.


