MINUTES

Motion by Mayor Pro Tem Westbrook to approve the June 10, 2020 minutes; seconded by Councilmember Sellers; motion carried 5 - 0 & approved as presented.

ZONING

Z-1 TABLED ITEM. Z20-013 MASTER CUSTOM HOMES INC (2603 GARDEN VALLEY ROAD AND 1403 SHAWNEE BOULEVARD)

Request that the City Council consider approving a zone change from "R-1A", Single-Family Residential District and "R-1B", Single-Family Residential District to "PUR", Planned Unit Residential District. This item was previously tabled at the City Council meeting on April 22, 2020, May 27, 2020 and June 26, 2020. (O-2020-71)

August 12, 2020

Motion by Mayor Pro Tem Westbrook to un-table the item from previous meeting; seconded by Councilmember McGee; motion carried 5 - 0 & item un-tabled and ready for discussion.

<u>Jake Fears, 121 S. Main St Henderson, Texas</u> – Stated that he was here representing the Developer and in support of the PUR presented today.

<u>Michael Gazette</u>, 100 E. Ferguson – Stated that he was here representing the Developer and he was for the project and would request that the City Council approve this project today to allow work to begin.

Gaylord Hughey, 305 Ferrell Place – Stated that he was here representing Willow Brook Country Club and that the club supports the development but it needs to protect its property. Mr. Hughey stated that this is a drainage and siltation issue and it's very common in the community. Hughey stated that they have a resolution that they would like to present to the Council. He stated that there was some allegation among the Engineers that there was some siltation run off associated with this part of this development, so they filed the protest accordingly. Hughey stated that they were tied up on one technical issue which has to do with what, if anything, can be done inside a natural Greenbelt. The Club wants the Council's clarification on whether it is going to be a natural Greenbelt, and whether or not they can go in and disturb the surface. Hughey stated that in the Club's estimation, it would defeat the purpose of the Greenbelt, which is to slow the run off, and catch the siltation, coupled with a drainage ditch that you will see on the plat. Hughey stated that the Club wants the development to go forward and they want to get Mr. Wasson started out there, but again the Club needs the Council's guidance.

Jack Wasson, 1265 Roma Dr., Frisco, TX 75036 -Owner and Developer of the property in discussion today. Mr. Wasson stated that this site plan for Garden Valley North has been put on hold for several months in order for them to work with the Planning Department to come up with a PUR property that Planning could support and that would allow development to proceed. Wasson stated that he spent a lot of time working back and forth with City staff, and everyone agreed that this was a good site plan. Wasson stated that the Greenbelt property is at least 2000 feet north of the property that is being considered, and the engineer will acknowledge that there is no water run off issue that effects Willow Brook in any possible way. The water that discharges from this property goes in a completely different direction. Wasson stated the issue with this property is that it is fifty (50) units. He said the lender anticipates the day when they will sell these units, and that's why they have subdivided it and provided for individual ownership of each unit. Wasson stated that these townhomes match Garden Valley South, which is fifty-four (54) units at this point. This project has the same floorplan, and the same building plan as Garden Valley South, which has already been approved by the Planning and Zoning Commission, has been platted, and has been approved by the City Council. Wasson stated that they are now here about Garden Valley North, which would double the size. He stated that his lender felt that the project was too small, the fifty (50) townhomes was not sufficient. He said that when the opportunity presented itself to acquire the property directly across the street, the lender strongly recommended that they increase the number of units and make this a hundred and ten (110) to a hundred and twenty (120) units.

Motion by Councilmember McGee; seconded by Councilmember McKellar; motion carried 5 - 0 & approved as presented.
