CITY MANAGER'S REPORT

- 1. The City is facing winter weather again this week into early next week. Currently it looks like temperatures will plunge beginning late Thursday with best chance of snow and freezing rain on Monday, February 15th. The street department will have plenty of sanding material and de-icer on hand. We also have a specific, as far as locations list that we are utilizing to ensure, in relationship to emergency operations, hospital operations those streets and roadways stay open. We will be closely monitoring the weather and have crews on standby in the event of winter weather later this week and into early next week.
- 2. The Tyler Trees Committee will be handing out over 2000 tree seedlings on Saturday, February 28 starting at 9:00 am at Christus Trinity Mother Frances south Tyler location on Broadway Avenue. The seedlings will be available on a first come first serve basis.
- 3. In addition, in honor of the 100th commemorative anniversary of the tomb of the Unknown Soldier received a donation of 20 white rose bushes donated to the Rose Garden from members of the Mary Tyler Chapter of the Daughters of the American Revolution. This was meant to resemble the tomb of the Unknown Soldier as well as designated in the northeast portion of the garden, which will be replanted this week in hopes of blooming for a ceremony that is scheduled for November 11, 2021.

- 4. We are quite excited because we had the opportunity late last week to brag about the fact that we are number one. We received a one in the ISO class ratings for our Tyler Fire Department in associated services, which means a reduction in insurance premiums for residents and businesses here in the city.
- 5. We are also excited that Tyler Texas ranked number 20 of the best cities for black women in the US. Moneygeek.com recently reviewed universities across America to find where black women are doing best in Tyler and ranked up there in the top 10 percent.
