## ZONING

**Z-1** Z21-009 ROOSTH INTERESTS 850 LLC (1418 WEST GENTRY PARKWAY AND 1001 AND 1003 MEADOW DRIVE)

> Request that the City Council consider approving a zone change for one lot containing approximately 0.42 acres of land located at the southeast intersection of West Gentry

Parkway and Meadow Lane from "C-2", General Commercial District to "R-1B", Single-Family Residential District. (O-2021-25)

M-5 Request that the City Council consider authorizing the City Manager to sign a temporary right-of-way use agreement with Carlos Barron, owner of Don Juan on the Square, for the purpose of installing and maintaining outdoor restaurant seating in the City of Tyler right-of-way.

Motion by Councilmember McKellar to approve with the waiver of 250.00 dollars; seconded by Councilmember Westbrook; motion carried 6 - 0 & approved as presented.

M-6 Request that the City Council consider authorizing the City Manager to ratify a reconciliation change order that will increase the contract amount by \$311,823.90 and the release of final retainage payment in the amount of \$68,511.55 to Reynolds and Kay, LTD for the Sanitary Sewer Open Cut Re-route Package DP06, BOND-CD-001-GM06 Standard Bid, 20-034.

C-A-14 Request that the City Council consider authorizing the City Manager to execute a contract amendment with Halff Associates in the amount of \$48,000 for additional services related to the Water Utility System Inventory project.

Motion by Councilmember Westbrook to approve the entire consent agenda; seconded by Councilmember Curtis; motion carried 6 - 0 & approved as presented.

### **CITY MANAGER'S REPORT**

- 1. Keep Tyler Beautiful gave the Tyler Native Plant Garden a facelift, and planted over 50 new native plants. The garden will be used this summer as an educational tool during the Summer Playground program and other school activities. On Saturday, Great Tyler Cleanup had more than 300 registered volunteers conduct a city-wide litter pickup. Locations included City parks, trails, creeks, campuses and streets. On Saturday, Keep Tyler Beautiful partnered with Tyler Legacy's Student Council to complete a beautification project at Rose Rudman. The student volunteers helped restore the large flower bed by laying down new landscaping brick and mulch.
- 2. Police Department The introduction of officers carrying Narcan has been a valuable resource for officers responding to emergencies. Over the past few years this has allowed trained officers to intervene in suspected overdose cases. We are a few of months away from having to replace our Narcan supply. We recently learned of a program that the Plano Police Department is utilizing to replace Narcan and Assistant Chief David Long spoke with a vendor that put us in touch with the UT Health San Antonio School of Nursing. Assistant Chief Long has completed the necessary request form and has been able to order 108 boxes (216 doses) of Narcan at no expense to the department or City. This replacement would have cost a minimum of \$7,500. It is our understanding that this process will be a continuous means of replacing supplies in the future. We appreciate Assistant Chief Long for his efforts in supplying this product.
- 3. Standard & Poor came out with an A+ stable outlook for our Hotel Occupancy Tax (HOT) credit rating. This is the highest that our financial advisor was expecting. Furthermore, this is the only HOT revenue bond that he is aware of that is not on negative outlook. They rated the General Obligation (GO) but are keeping it internal and would not tell our financial advisor what it is. However, since the HOT rating is based on the GO, he provided some deductions based on the following recent ratings:

Amarillo HOT – A+ negative outlook

Amarillo GO – AAA negative outlook

Round Rock HOT – A+ negative outlook

Round Rock GO – AAA stable outlook

Tyler HOT – A+ stable outlook

Tyler GO – can be probably expected to be AAA Stable on your general obligation side.

We appreciate the work that Mayor Warren, Keidric Trimble, Stephanie Franklin, Shari Lee, and our financial advisor team of Steven Adams and Specialized Public Finance Inc. did on this credit rating assessment.
