ZONING

Z-1 A21-001 NATIONAL RETAIL PROPERTIES LP AND FIKES WHOLESALE INC (8604 HIGHWAY 64 EAST AND 5.03 ACRES OF LAND)

Request that the City Council consider adoption of an Ordinance providing for the voluntary annexation of approximately 5.16 acres of land and adjacent right-of-way lying adjacent to the present boundary limits of the City of Tyler located at the southeast intersection of Highway 64 East and County Road 219. Also consider:

A. The new boundary of the City Limits.

B. The new boundary of the City Council District #4.

CITY MANAGER'S REPORT

- 1. Tyler has been ranked number 17 in top 20 "Safest Cities in Texas for 2021" by safety.com. Safety.com. resource for all things safety, reviewed comprehensive data from cities and townships statewide, ranking Tyler in the top 20 for its combined ranking of public safety scores including the most recent crime statistics and financial security metrics.
- 2. Texas Legislature gives approval to new UT medical school in Northeast Texas Authorization for the Health Science Center at UT Tyler to allocate its resources to attain accreditation of a doctor of medicine (MD) program—a step needed to create a new medical school—has passed through the Texas Legislature and will soon be on its way to Governor Abbott's desk for signature. The authorization is included in Senate Bill 1, the state's biennial budget.
- 3. Grant for Rose Complex Park The City of Tyler Parks and Recreation Department received the Texas Parks and Wildlife Department Local Parks Grant for the Rose Complex Park totaling \$749,999. The Local Parks Grant funds the development and acquisition of public recreation areas and facilities throughout the State of Texas.
- 4. Soccer campers rushed to safety by Parks Department staff at Lindsey Park during Tuesday morning tornado. About 25 children between the age of 9 and 16 were participating in a soccer camp at Lindsey Park on Tuesday morning when they were rushed off the fields into the park restrooms as a tornado was seen heading straight to the soccer fields. Lindsey Park Crew Leader Dorean Lindsey said his team spotted the tornado and began working to get the children and coaches off the field and into the restrooms where they could take cover.
