ORDINANCE

O-1 Request that the City Council consider adopting an Ordinance amending Tyler City Code Chapter 17, to include new bicycle routes associated with the Bike Stripes project, to remove portions of old bicycle routes that are no longer applicable due to the Bike Stripes project, deleting driving and parking restrictions associated with exclusive bicycle lanes,

deleting unnecessary references to penalties, and amending the official map to show all designated signed bicycle routes within the City of Tyler. (O-2021-73)

M-1 Request that the City Council consider authorizing the City Manager to execute an engineering contract with The CT Brannon Corporation for the Grande Boulevard Reverse Curve Preliminary Engineering Report and Highway Safety Improvement project screening and applications in the amount of \$95,943.00.

August 11, 2021

- 1. The 8th Annual #SchoolisCool event took place as a drive-thru event at Fun Forest Park yesterday. Thanks to the continued partnership between the City of Tyler, Tyler Area Business Education Council, and TISD, we were able to distribute nearly 2,000 backpacks to school children. Though this event wouldn't have been possible without the generous donations from over fifty local sponsors and the enthusiastic volunteers, including the entire TJC Apache football team. We appreciate Councilman Westbrook and Councilman Wynne coming out to help support the event. We had a lot of grateful parents and happy kids.
- 2. We had our End of the Summer picnic at the Glass Recreation Center last Friday to close out our summer camps. A special thank you to Tyler PD for cooking for the kids they really enjoyed it! We also would like to thank those who stopped by to serve food and join in on the fun. Councilman Bob Westbrook, Councilman James Wynne, Stephanie Franklin, Chief David Coble, Chief Jimmy Toler, Keidric Trimble as well as LaToya Young (Business Education Council) for providing school supplied backpacks to each child! Last but not least, we are grateful for each member of the Parks & Rec team that helped make this summer a success and gave the kids a safe place to make memories!
- 3. Homeless Outreach and Clean Up For several months, individuals have been staying under the bridge at Spring and Valentine. At one point there were approximately 30 tents under the bridge. The Police Department (through Officer Johnny Green) has worked with the Tyler Street Team to handle the constantly evolving situation. Several individuals had found transitional housing, moved to shelters and returned to family members. On August 9, 2021, members of the Police Department, Code Enforcement and Solid Waste worked to clean and mow the area.
