CITY MANAGER'S REPORT

- 1. 2020 Census: The Census Bureau released preliminary data related to the 2020 Census today that provides for count data at a general level for cities, counties and states. For Tyler, our 2020 count came in at 105,995 residents. This is a 9.39% growth over the 2010 Census count of 96,900 residents. We do believe that the count was lower than the actual number of residents in Tyler, but understand that the census count was difficult last year due to multiple factors.
- 2. **TWU Annual Chlorine Conversion:** We are proposing to schedule the free chlorine conversion from Monday, October 4, and end it on Sunday, October 31. This will start after the East Texas State Fair. There isn't a simple way to avoid the Rose Festival, but their activities should not be affected by the free chlorine conversion.
- 3. Pipeline Analysis will be smoke testing sewer lines in sewer meter basins 13 and 17 as part of the City's ongoing sanitary sewer inspection program. The testing will be conducted from 8 a.m. to 5 p.m. through Friday, Aug. 20th.
