The City of Tyler has 138 school speed zones within the City of Tyler. One hundred twenty-seven of these school speed zones occur on City streets while the remaining 11 are found on TxDOT maintained streets within the City Limits. The school speed zone speed limits on these streets vary from 20 mph to 35 mph. The speed differential ranges from 5 mph to 15 mph between the standard posted speed limit and the school zone speed limit.

In order to improve safety for pedestrians within school speed zones and provide more uniformity/consistency on school speed zone with the City of Tyler a review was completed of the existing school speed zones. It is recommended to make changes at 11 schools to reduce school speed zone speeds to 20 mph.

It is also recommended to remove the school speed zone on SSE Loop 323 for Clarkston Elementary. This school zone was removed from operation before the beginning of the 2022-2023 school year through coordination with Tyler ISD.

There are also minor spelling modifications recommended to school speed zones associated with Dixie Elementary.

Lastly the addition of one school speed zone at Jack Elementary is recommended. It appears this school zone speed zone was inadvertently removed during the last school zone ordinance update.

RECOMMENDATION:

It is recommended that the Traffic Safety Board recommend to the City Council to adopt an ordinance amending Tyler City Code Chapter 17, by modifying or removing school speed zones for Andy Woods Elementary, Boulter Middle School, Caldwell Elementary, Clarkston Elementary, Cumberland Academy, Griffin Elementary, Hubbard Middle School, Jack

Elementary School, Moore Middle School, Ramey Elementary, Rice Elementary, Tyler Legacy High School, and UT Tyler University Academy.

REVIEW OF SCHOOL SPEED ZONES FOR MULTIPLE SCHOOLS WITHIN THE CITY OF TYLER

Texas Transportation Code Section 545.356 and City Code Section 17-61 authorize the City Council to establish speed limits, on the basis of engineering and traffic studies and the recommendation of the Traffic Engineer.

Tyler City Code Section 17-64a. states that the Traffic Engineer shall designate school traffic zones with appropriate street markings or signs. These decreased speed limits for school zones shall be for hours designated on school days, where school signs are posted or at any time when electrical control devices are in operation advising motorists of the speed limit in the school zone.

In order to improved safety within school zones and create more uniformity and consistency for school zones speeds within the City of Tyler the Traffic Engineering staff reviewed the existing schools within the City of Tyler. Staff is recommending modifications to school speed zones at the following schools: Andy Woods Elementary, Boulter Middle School, Caldwell Elementary, Clarkston Elementary, Cumberland Academy, Griffin Elementary, Hubbard Middle School, Jack Elementary School, Moore Middle School, Ramey Elementary, Rice Elementary, Tyler Legacy High School, and UT Tyler University Academy.

The modifications, with a few exceptions, will bring the school speed zones to 20 mph at these schools.

Traffic Engineering staff is also recommending of the school speed zone located on South Southeast Loop 323 associated with Clarkston Elementary. The operations of this school zone speed were discontinued at the beginning of the 2022-2023 school in coordination with Tyler ISD.

Additional changes are being made to reflect the updated names of schools and to correct current wording.

REVIEW BY TRAFFIC SAFETY BOARD

City Code Section 17-30.c. states that the Traffic Safety Board shall make recommendations through the Traffic Engineer regarding safety as it deems necessary. On February 2, 2023, the Traffic Safety Board had discussions regarding the proposed school zone speed zones and voted to recommend approval of this Ordinance to City Council.

RECOMMENDATION:

It is recommended that City Council adopt an ordinance amending Tyler City Code Chapter 17, by modifying or removing school speed zones for Andy Woods Elementary, Boulter Middle School, Caldwell Elementary, Clarkston Elementary, Cumberland Academy, Griffin Elementary, Hubbard Middle School, Jack Elementary School, Moore Middle School, Ramey Elementary, Rice Elementary, Tyler Legacy High School, and UT Tyler University Academy.

ORDINANCE NO. 0- 2023-

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, AMENDING TYLER CITY CODE CHAPTER 17, "STREETS AND TRAFFIC", ARTICLE III., "SPEED REGULATIONS", BY MODIFYING OR REMOVING SCHOOL SPEED ZONES FOR ANDY WOODS ELEMENTARY, BOULTER MIDDLE SCHOOL, CALDWELL ELEMENTARY, CLARKSTON ELEMENTARY, CUMBERLAND ACADEMY, GRIFFIN ELEMENTARY, HUBBARD MIDDLE SCHOOL, JACK ELEMENTARY SCHOOL, MOORE MIDDLE SCHOOL, RAMEY ELEMENTARY, RICE ELEMENTARY, TYLER LEGACY HIGH SCHOOL, AND UT TYLER UNIVERSITY ACADEMY; PROVIDING FOR APPROPRIATE SIGNAGE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, it is the intent of the City Council to protect the public health, safety, and welfare; and

WHEREAS, Texas Transportation Code Section 545.356 provides that the governing body of a municipality, for a highway or part of highway in the municipality, has the authority to alter by ordinance prima facie speed limits from the results of an engineering and traffic investigation; and

WHEREAS, Texas Transportation Code Section 545.356 states that a prima facie speed limit that is altered by the governing body of a municipality is effective when the governing body erects signs giving notice of the new limit and at all times or at other times as determined; and

WHEREAS, Tyler City Code Section 17-61.a. provides that the Traffic Engineer shall determine on the basis of engineering and traffic surveys, the reasonable and safe maximum speed limits for each City street and submit recommendations based on such investigation to the City Council; and

WHEREAS, Tyler City Code Section 17-61.b. provides that on the basis of recommendations of the Traffic Engineer, the City Council may alter speed limits deemed necessary; and

WHEREAS, Tyler City Code Section 17-64 establishes specific school speed zones; and

WHEREAS, Tyler City Code Section 17-62 provides that the Traffic Engineer shall post the maximum and minimum speed limits, if any, by appropriate signs in conspicuous places so that every motorist may be aware of the speed limits; and

WHEREAS, Tyler City Code Section 17-30.c. states that the Traffic Safety Board shall make recommendations through the Traffic Engineer regarding traffic safety as the Board deems necessary;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS:

PART 1: That Tyler City Code Chapter 17, “Traffic”, Article III., “Speed Regulations”, is hereby amended by amending the following school speed limits in Section 17-64 in the appropriate alphabetical order to read as follows, with no other changes:

Sec. 17-64. School speed zones.

Sec. 17-64. School speed zones.

a. In general. The Traffic Engineer shall designate school traffic zones with appropriate street markings or signs. These decreased speed limits for school zones shall be for hours designated on school days, where school signs are posted or at any time when electrical control devices are in operation advising motorists of the speed limit in the school zone.

b. When traffic control devices or signs are erected giving notice thereof, the prima facie speed limit shall be either twenty (20), twenty-five (25), thirty (30) or thirty-five (35) miles per hour on the following streets or portions of streets:

PART 2: That the Traffic Engineer is hereby directed to remove any existing signage that is no longer necessary and to post all appropriate new signage, as required by Tyler City Code Section 17-62, so that every motorist will be aware of the altered speed zone limits.

PART 3: That if any provision or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way affect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 4. That any person, firm, or corporation violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be punished by a fine as provided in Section 1-4 of the Tyler Code. Each day such violation shall continue, or be permitted to continue, shall be deemed a separate offense. Since this ordinance has a penalty for violation, it shall not become effective until after its publication in the newspaper as provided by Section 85 of the Charter of the City of Tyler, Texas, which date is expected to be January 14, 2022.
