A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TYLER, TEXAS, INDICATING SUPPORT FOR THE APPLICATION GLENWOOD GARDENS REALTY, LP AND ITS AFFILIATES, AFFORDABLE RENTAL HOUSING DEVELOPMENT KNOWN TEXAS DEPARTMENT **OF** GLENWOOD GARDENS, TO THE **COMMUNITY FOR** THE 2022 **AFFAIRS** HOUSING AND **COMPETITIVE NINE-PERCENT** HOUSING TAX CREDITS, APPROVING A WAIVER OF DEVELOPMENT /PERMIT FEES IN THE OF \$500.00. AUTHORIZING THE MAYOR AND/OR DESIGNATED CITY STAFF TO TAKE ALL NECESSARY OR **ASSOCIATED** THEREWITH; AND APPROPRIATE **ACTIONS** ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, it is the intent of the City Council to promote the general public welfare; and

WHEREAS, it is the intent of the City Council to promote and encourage affordable housing; and

WHEREAS, Glenwood Gardens Realty, LP and its affiliates have proposed the construction of the development of affordable rental housing known as Glenwood Gardens located at 111 Barron Avenue in the City of Tyler, Smith County, Texas; and

WHEREAS, Glenwood Gardens Realty, LP and its affiliates have communicated that they intend to submit an application to the Texas Department of Housing and Community Affairs for 2023 Housing Tax Credits for the Glenwood Gardens development; and

WHEREAS, Glenwood Gardens Realty, LP and its affiliates have requested a waiver of development/permit fees in the amount of \$500.00 for the Glenwood Gardens development as a commitment of development funding from the City of Tyler, Texas; and

WHEREAS, as noted in Tyler City Code Section 1-9, the City Council has the authority to refund, transfer or waive any fee when, in its sole discretion, it determines that circumstances justify such action in order to promote a public purpose or the public welfare; and

WHEREAS, the City of Tyler, Texas has the authority to defer development fees on the property located 111 Baron Avenue, Tyler, Texas;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TYLER TEXAS:

Part 1: That the City of Tyler, acting through its governing body, hereby confirms that it supports the proposed Glenwood Gardens proposed to be located 111 Baron Avenue and that this formal action has been taken to put on record the opinion expressed by the City of Tyler on February 22, 2023.

Part 2: That the City Council, as governing body of the City of Tyler, Texas, hereby adopts this Resolution as evidence to its commitment of funds in the amount of \$500.00 to be provided to the development in the form of a waiver of development /permit fees.

Part 3: That for and on behalf of the governing body, Donald P. Warren, Mayor, and/or designated City Staff, is hereby authorized, empowered and directed to certify this Resolution to the Texas Department of Housing Community Affairs and to take all other necessary or appropriate steps or actions associated with this development funding.

Part 4: That this Resolution shall be effective immediately upon adoption.
