
The following persons have passed the written promotional examination for the position of **Fire Driver/Engineer** given on **April 25, 2023**, and meet all minimum qualification requirements for the classification. Promotional candidates are listed in order of their final score, which consists of their test score of 70 or more, plus seniority points up to a maximum of 10, for all service as a Civil Service employee in the City of Tyler. In cases where the final score was the same, the tie-breaking procedure in the City of Tyler Police Officers' and Firefighters' Civil Service Commission Regulations was used to break the ties. This eligibility list will remain in effect for one year from the date of the test. It is set to expire on April 25, 2024 at 11:59:59 p.m., unless exhausted before that date.
